

# Wild Labradors Foster Program Contract

This Foster Agreement is made on May 27, 2025 between Wild Labradors (Monica Wild) and **Divyanshi**, the approved foster caretaker of **Ruckus**, a **N/A N/A** Labrador Retriever, born on **Unknown DOB**, with microchip number **N/A**.

## 1. Our Mission

At Wild Labradors, we believe in raising exceptional English Labradors in loving, home environments. This foster agreement ensures each breeding dog lives a fulfilling, well-rounded life while contributing to a responsible and ethical breeding program.

## 2. Contract Term & Participation

This agreement remains valid until the dog reaches the end of its breeding eligibility — age 5 for females and up to age 7 for males — unless otherwise agreed upon. Foster families must maintain open communication and attend scheduled drop-offs and pick-ups for breeding and whelping (for females) or stud services (for males).

## 3. Compensation

Foster families are compensated for their commitment as follows:

- **Females:** \$2,000 per litter of 3 or more live puppies, payable after puppies go home at 8 weeks.
- **Males:** \$500 per successful breeding match confirmed by Wild Labradors.

Compensation is issued promptly upon milestone completion.

## 4. Veterinary Care & Expenses

Wild Labradors covers all breeding-related medical expenses, including fertility evaluations, pregnancy management, and whelping support. Routine wellness care, injuries unrelated to breeding, and emergency visits are the foster's responsibility unless otherwise approved by Wild Labradors.

## 5. Foster Responsibilities

Fosters are expected to provide daily care, proper nutrition, exercise, and emotional enrichment. Dogs must be safely contained (e.g., fenced yard or supervised outings). Drop-off and pick-up compliance is required. Non-compliance may result in termination of the agreement and rehoming of the dog.

## 6. Wellness & Communication

Monthly check-in forms must be submitted. Any significant behavioral or health changes should be reported immediately. Failure to maintain the dog's health, safety, or environment will result in contract termination.

## 7. Termination & Penalties

This contract may be terminated at any time by the foster with the return of the dog to Wild Labradors. Violation of this agreement — including refusal of drop-off, neglect, or failure to return the dog — may result in forfeiture of the

dog and a penalty up to \$20,000 for breach of contract.

## **8. Agreement**

By signing below, both parties agree to uphold the terms and spirit of this agreement, ensuring the safety and wellbeing of the dog while honoring the mission of ethical, responsible breeding.
